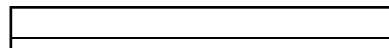

APPLICATION INSTRUCTIONS

1. This parcel tax exemption is for property owners who are over 65 years of age or older by July 1, 2024.
2. This parcel tax exemption is for your principle place of residence only and applies to one parcel, or one unit of a multiple family structure, only.
3. **You only need to apply one time for the 65 years of age or older exemption.** If your application is approved, you will be eligible to receive the exemption for the entire term of the parcel tax, so long as you continue to own and occupy your principal place of residence.
4. To find your Parcel Number, look for the nine-digit number (XXX-XXX-XXX) on your property tax bill, or call the County Assessor at (925) 313-7400.

6. **Return by May 1, 2024.** Applications received after this date will be submitted for the following tax year. Prior year refunds will not be granted.
7. Any parcel tax that was previously levied on your tax bill is not refundable.
