IPM statement

It is the goal of Orinda Union School District to implement IPM by focusing on long-term prevention or suppression of pests through accurate pest identification, by frequent monitoring for pest presence, by applying appropriate action levels, and by making the habitat less conducive to pests using sanitation and mechanical and physical controls. Pesticides that are effective will be used in a manner that minimizes risks to people, property, and the environment, and only after other options have been shown ineffective.

Our pest management objectives are to: *(Example: Focus on long-term pest prevention)*

Focus on long-term pest prevention. Continue to keep facilities clean so the use of any pesticide is as minimal as possible. We will continue to use herbicide minimally and when staff and students are not present.

Pest identification, monitoring and inspection

Work orders are submitted following a pest inspection or identification of pests. These include location and date. Work orders identify the technique used. When used, sticky traps are monitored and inspected by custodial staff.

Chemical pest management practices

If non-chemical methods are ineffective, the school district will consider pesticides only after careful monitoring indicates that they are needed according to pre-established action levels and will use pesticides that pose the least possible hazard and are effective in a manner that minimizes risks to people, property and the environment.

This child care center expects the following pesticides (pesticide products and active ingredients) to be applied during the year. (This list includes pesticides that will be applied by school district staff or licensed pest control businesses.):

The Orinda Union School District only uses herbicides where citrus based herbicides such as Avenger Weed Killer containing orange oil prove to be ineffective. Round-up herbicide is no longer used by the Orinda Union School District staff effective June 27, 2016.
